

SUMMARY ANNUAL REPORT
FOR AIRCONDITIONING AND REFRIGERATION INDUSTRY
DEFINED CONTRIBUTION RETIREMENT PLAN

This is a summary of the annual report for the Airconditioning and Refrigeration Industry Defined Contribution Retirement Plan, E.I.N. 58-1855968, Plan No. 001, for the year ended December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$7,141,966. These expenses included \$440,397 in administrative expenses and \$6,701,569 in benefits paid to or for participants and beneficiaries. A total of 2,779 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$144,808,951 as of December 31, 2018, compared to \$150,368,977 as of January 1, 2018. During the plan year the plan experienced a decrease in its net assets of \$5,560,026. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$1,581,940 including employer contributions of \$1,564,455, employee contributions of \$4,499,124, rollovers of \$216,410, losses from investments of \$5,130,571 and other income of \$432,522.

2. financial information and information on payments to service providers;
3. assets held for investment; and
4. information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.
